Meeting Minutes

1. Minutes of the Previous AGM Minutes (14 September 2019)

2. Committee's Report

Michael Roxburgh presented the Executive Committee's Report. Below you will find a summary. The full report was circulated with all members via email on the 12th September 2020.

This was a challenging year because of the Covid-19 pandemic. It was pleasing to see all of the regions trying to maintain their activities and it was great to see the response and collaboration of the regions when facing the different challenges.

Main points:

- New club is in the initial formation stage in Southland
- Dr Eoin Murray provided coaching courses and referee courses which resulted in eight (8) NZHF members receiving the IHF Coaching D license and further nine (9) had their waiting for the exam results.
- The Senior Men team went to the Asian Championships in January 2020 hosted in Kuwait. Besides world political tensions in the Middle Eastern region, the team did well and with Luke Ireland, the NZHF had the main top goal scorer of the competition.
- The incumbent Senior Men Coach has been appointed to another campaign aiming for the Asian Championships 2022
- Various NZHF beach teams attended in February 2020 the Australian Beach Open Championships, this also
 included the NZHF Beach National teams faced their counterparts in friendly matches during that
 weekend.
- A high performance framework had been drafted, focusing on 3 key areas development, sustainability and performance
- Because of COVID-19, unfortunately, the IHF Trophy Oceania has been postponed/cancelled and therefore our youth and junior programs were heavily impacted by this
- Special mention to our Media Officer, Jun Tanlayco, who again contributed massively promoting New Zealand Handball activities from within New Zealand, but also while travelling with NZ teams overseas. As a bonus, the Oceania Handball Federation (OCHF) and the International Handball Federation (IHF) were also using some of Jun's footage to promote Handball.
- Still in 2019, we have successfully completed our National Club Championships and an inaugural Junior Regional Championships.
- We also organised an highly successful NZHF exhibition match in Wellington between the NZ Senior men team and a NZ Barbarians team, supporting the NZ Senior men team in the direct lead up to the Asian Championships
- Unfortunately, due to COVID-19, we had to cancel our High Performance tournaments (National Club Championships, Regional Championships) in 2020, though, we were still able to run local Handball activities (South Island shield, Wellington League, Otago league, and the Auckland Open Championships)
- · We secured grants from the Olympic Committee and the IHF, further grant applications are in the pipeline
- · While our communication improved, we still understand we need to improve further in that area

Michael Roxburgh thanked members of the committee for their work in the previous year.
